The General Fund reserve amount was taken from the 2017-2018 Adpoted Budget. Utility reserve targets were calculated based on the policies in Section 6 of Resolution No. 2016-19. Operating expenses used in the calculation were taken from the 2017-2018 Adopted Budget, and capital assets used in the calculation were taken from the 2016 CAFR.

Monthly revenue and expense amounts may include non-cash transactions.

December 2017 ending fund balances are not finalized and are subject to change through April 2018.
